Will hold Ride Management, all ride personnel and all property owners over whose land the ride crosses blameless for any accident, injury or loss that might occur due to my participation in the Iron Mountain Jubilee Endurance Ride and free from all liability for such injury or loss **to the extent allowable by Virginia State law**.
